## **Notice from Tradecom S.r.l. under Art. 13-14 EU Regulation 2016/679**

### **Data Controller**

We inform you that, under EU Regulation 2016/679 (hereinafter the "**Regulation**"), Tradecom S.r.l., with its registered office in Viale del Lavoro n. 8 – 37135 Verona, will be the data controller ("**Data Controller**") for your personal data, collected for the purpose of evaluating application for possible employment.

### **Types of personal data processed**

### **Method of the processing**
